Allow extra time at the American Revolution Museum at Yorktown to view the introductory film, *Liberty Fever*, and shop in the museum store.

American Revolution Museum at Yorktown

Take in the Revolution through dynamic gallery exhibits, films and outdoor living history.

The American Revolution Museum at Yorktown tells the story of the nation's founding, from the twilight of the colonial period to the dawn of the Constitution and beyond. Exciting indoor galleries feature period artifacts, immersive environments and films, including "The Siege of Yorktown," with a 180-degree surround screen and dramatic special effects.

In the outdoor areas, visit a re-created <u>Continental Army encampment</u> to learn about the life of a soldier and take in daily demonstrations on medical treatment, camp life and cooking, and see firings of a flintlock musket. Explore a <u>Revolution-era farm</u>, based on a real-life 18th-century family, to help with chores in the house, kitchen, tobacco barn, gardens and crops.

IN MEMORIUM — THOMAS WETHERELL 8 STEPTOE JR (Thos W 7 Phil P 6 Chas Y 5 Thom 4 Jas 3 Eliz 2 Geo 1) was born 25 April 1951; died 23 January 2022 Charles Town WV. He served as EFA President for 2 terms and greatly aided in the transition after the retirement of Coz. Elizabeth Coiner.

Thomas Wetherell Steptoe, Jr. 70, passed away on January 23, 2022.

He was the son of the late Thomas W. Steptoe and Margaret Crane Steptoe and the grandson of Philip Pendleton Steptoe and Mary Louise Wetherell Steptoe & Charles L. Crane and Anne Lionberger Crane.

He was a Senior Status Circuit Court Judge and a former Legislator (House of Delegates) and a retired WV Circuit Court Judge.

He is survived by his beloved wife of 39 years, Sharon Menefee Steptoe; by a daughter, Dr. Anne Parrish Steptoe of Charlotte, NC, and her husband, Robert Short and a son, Philip Pendleton Barbour Steptoe of Hurricane, WV and his wife, Casey Baker Steptoe.

He grew up in Charles Town. He attended Miss Ollie Blessing's Kindergarten, the Public Schools of Jefferson County, WV and graduated from the Episcopal High School in Alexandria, VA, where he received the William Bee Ravenel "E" Club Award for Effort, Service and Sportsmanship in Athletics and the William Garrett Bibb Award for Excellence in Shakespeare. Thereafter, he earned a Three-Term Certificate from The University of St. Andrews in Scotland where his work concentrated on the study of Anglo-Saxon language and literature. In 1974, he earned his BA "with distinction" (the equivalent of a "cum laude") in English from the University of Virginia. Then, in 1977 he earned his JD from the West Virginia University College of Law. Then, also in 1977, he became an associate of the law firm of Avey, Steptoe, Perry, Van Metre & Rockwell. In 1980, at age 29, he was elected to represent Jefferson County in the West Virginia House of Delegates. He served two terms as a Delegate as a member of the House Judiciary Committee, the Health & Welfare Committee and as Vice-Chairman of the Natural Resources Committee. While in the Legislature, he pursued a number of issues but, in particular, strived for single-member house of delegate districts, restitution, and crime rights, as well as initiatives to preserve farmland. In 1984, at age 33, he was elected Circuit Court Judge, 23rd Circuit, which encompassed Jefferson, Berkeley & Morgan Counties, to which position he was twice re- elected to successive 8year terms. He was one of the youngest persons to ever be elected to this position. The docket which he assumed upon his election was one of the most problematic in the entire state and was in danger of collapsing under its own weight. Through a combination of cooperation with the West Virginia Supreme Court of Appeals docket reforms and increasing court operation hours he was able to render the docket effective and efficient. Steptoe was twice appointed as a temporary supreme court justice, including to the controversial Oakley v. Gainer case. This case was a follow-up to a previous Supreme Court of Appeals decision in the notorious case of In Re Dostert, in which the supreme Court had in effect, substantially rewritten the Judicial pension statue, rendering its already generous provisions more accessible to former judges. In Oakley, the Petitioners were seeking to force the State Auditor to honor the new rules laid down by the Supreme Court in Dostert on the basis that the same constituted binding legal precedent, i.e., "stare decisis." As the case developed, however, Steptoe came to believe that the holding of the Court in Dostert should not be followed as legal precedent because the holding violated the Constitutional separation of powers doctrine. In short, Steptoe believed that the State Constitution vested issues concerning the compensation of judicial officers solely and exclusively in the Legislature, thus rendering the judiciary without jurisdiction to alter the same. Nevertheless, the majority of the panel in the Oakley case voted to uphold and follow the Dostert decision. Steptoe then wrote a strongly worded and at the time a frequently quoted dissenting opinion. Six years later, the issue was revisited in the case of Harshbarger v. Gainer, the Supreme Court of Appeals reversed its holding in Dostert and stated the following in its ruling: "We declare that by the lavish expansion of the judicial retirement system in Dostert, this Court invaded rights that were reserved by the Constitution of the State of West Virginia to the legislature...It is for these reasons that we now strike the fatal blow to the judicial retirement system written by the Court in Dostert and Depond. As the effacers of our past mistakes, we neither point a finger nor claim credit. Justice Neely dissented in Dostert, Justice Brotherton dissented in Depond, and circuit Judge Steptoe, sitting on a special panel in Oakley, dissented. Except for these judges, and one or two others, we acted more like children in a candy store than responsible public officials."

In 2009, after twenty-four years of active service, Judge Steptoe retired was immediately appointed as a senior status West Virginia circuit court judge, a position that he has held ever since. During his tenure as a senior status circuit court judge, he presided over cases assigned to him by the West Virginia Supreme Court of Appeals in approximately 20 of West Virginia's 55 counties.

The family is planning a memorial service to be held in the spring. We will provide more details as they become available.

Father of all, we pray to You for those we love, but see no longer: Grant them Your peace; let light perpetual shine upon them; and, in Your loving wisdom and almighty power, work in them the good purpose of your perfect will; through Jesus Christ our Lord. Amen.
